 - Meeting List Report: (Lisa P.) - The Thursday night Randolph 7:30 p.m. meeting has disbanded.
- Treasurer (Bob G) – Not present
- Literature (David B) – Got new shipment of literature and sold a book to a meeting in Worcester. FWS no longer sells printed cover “Sex and Love Addicts Anonymous” books. David will remove obsolete items from the report.
- Activities Committee including Vermont (Peter S) – We Are Not Alone Valentine’s Day event is this Saturday, February 14 in Brookline. Still need a speaker. Our event begins right as another event ends, so there may be some confusion when we start. Tentative date for Spring Gathering is on Saturday, April 25 at Andover-Newton Theological School. We have a 20% discount on price, so it will be \$950 as before with 3 small breakout rooms plus the large room. It’s \$900 if we only want 2 breakout rooms. Discussion. Consensus is to use 3 breakout rooms at ANTS for \$950. **Motion to spend \$950 on 4 rooms at ANTS (Wil/John): 4-0-1.** Upcoming Vermont weekend in March: early registration deadline is February 27. Currently have 1 facilitator and 4 attendees signed up. Local retreat: Patrick resigns as local retreat coordinator. We may be able to use the place in Attleboro.

- Outreach and Outreach Committee (Wil C) – Wil has been talking to someone at New Hampshire meetings. Working on the outreach page for the new web site. Would like to start working on Group Visitations again. S.L.A.A. Board of Trustees is working on clarifying the 300 word rule for reuse of materials. Wil asks for pamphlets for Massachusetts Treatment Center. U.K. Intergroup is sending S.L.A.A. Basic Texts to all prison libraries. CPOC is looking for part-time IT worker. Suggestion to pay for materials sent to Bridgewater MTC. Also suggestion to have donation bucket at Spring Gathering. Discussion about how to get materials to groups. Tabled until next month.
- ABM Delegate (Wil C) – Minutes from 2014 ABM are available, but need to request a password to access them. Wil is registering for ABM, asking NEI to pay for extra days of travel on Monday and Saturday due to health reasons.
